Minutes of the Meeting of the Parish Council held on 26 March 2024 in the Newington Room, Newington Village Hall

Proposal: Approval of reserved matters (Appearance, Layout, Scale and Landscaping sought) for erection of 46no. residential dwellings, with access from A2 High Street, pursuant to 21/505722/OUT.

Concerns were raised regarding biodiversity and protected species inhabiting the site; proximity to existing houses; over-looking; removal of the landscaping screening; current lack of GPs; demolition has started and a water main has been hit; working hours during construction; and archaeology of the area.

SBCllr R Palmer informed the meeting that he has called the application in to Swale Planning Committee.

Proposal: Conversion of existing barn to holiday accommodation with car port and cycle store. Cllr Harvey proposed to object to the application as it is outside the built-up area; it is in a Conservation Area; and there is no evidence for the need for a holiday let as Newington is not a holiday destination. Previous holiday lets were used for residential lets.

KCCllr Baldock reported he has spent a lot of time with KCC Highways due to the chaos in the Borough and had attended a meeting with Swale Borough Councillors, County Councillors and KCC Highways. It was hoped for involvement with local matters and to be able to raise

concerns, but this did not happen. Currently, there are a lot of school appeals. He is working with Vibe regarding youth provision for the summer. Concern has been raised regarding PROW as foot paths are being closed before the diversion is in place.

Cllr R Palmer thanked KCCllr Baldock for his report.

SBCllr R Palmer reported that he had attended a meeting with KCC Highways and also the Swale Western Area Committee.

SBCIIr C Palmer reported that she will contact Swale Planning to look at the layout of the proposal for 128 High Street. This has been the first week of the new bin collections and the transition has gone well.

SBCllr R Palmer said no problems have been reported in Newington, although there was a problem in Upchurch as the schedule on the letters did not agree with the Swale website.

SBCIIr C Palmer said Swale Borough Council has stated its new five-year plan. Two reports of fly-tipping have been submitted and this has been cleared. Some pot holes in Station Road have been repaired but new ones have appeared.

Cllr R Palmer informed the Council that Swale has two more covert cameras to tackle fly-tipping in the area.
