Cllr S Harvey said that if the Parish Highways Improvement Plan is put forward Michelle Matthews, Schemes Project Manager KCC Highways, could be asked to install an extra bollard outside Charlotte Court and the Parish Council could fund the roundels.

Cllr Jackson said the roof has been repaired twice and a contractor has said the roof needs replacing. Advice from another contractor is that the tiles should be re-used. The leak is further up the roof and is running down.

## 10. SWALE BOROUGH COUNCIL LAND

Cllr S Harvey said the Parish Council has requested three pieces of land, the first part of the track by the Recreation Ground; the area at the top of Orchard Drive to the vehicular access gate to the Recreation Ground and the area by the bus stop.

## **11. ALLOTMENTS**

Cllr Layer reported that there were a few vacancies at the allotments. Cllr Mould thanked Cllr Layer for his report.

## **12. VILLAGE VOICE AND MEDIA**

Cllr Mould said there will be an article on the forthcoming Celebration of Village Activities; pre-Covid the Council had invited all groups to the Annual Parish Meeting and this was extremely successful. The pandemic meant that this could not be repeated and the Annual Parish Meeting 2022 was too early as Covid was still a problem so a special meeting will be held on 8 September. The next edition of the Village Voice will be a paper edition and will include an article on The Cherries; invitation for residents to join the Adult Exercise Equipment Committee; the PCSO surgery; the church draw; St Mary's Treasurer vacancy; and planning.

### 14. CHURCHYARD AND CEMETERY

Cllr Layer reported that the plinth has been installed ready for the memorial bench. The grass has been cut. Volunteers are planting flowers behind the church.

Cllr Mould asked for an update on the church gate.

Cllr Layer said nothing more has been discussed.

Cllr Mould thanked Cllr Layer for his report.

## **15. HIGHWAYS**

Cllr Layer said there is a pot hole under the railway bridge which is getting worse, this has been reported to Swale Borough Council who have passed the matter to SGN. Nothing has been done. Cllr Layer informed Members that he had reported the fly tipping in the lane with no name and nothing has been done, more fly tipping has occurred further down the lane. *ACTION: Report to SBCllr Palmer.* 

### **16. STREET LIGHTING**

There was nothing to report.

## 17. BUMPY ALLEY

Cllr S Harvey said KCC has confirmed the alley is not theirs and Swale Borough Council has said it does not belong to them. A concern is that if the Council were to cut back the weeds, the Council might be accepting liability in the future. The alley was possibly a farm track.

Cllr Layer said the residents could cut back the area if they wanted this to be done, most people do not know where it is.

Councillors **AGREED UNANIMOUSLY** not to take action at this stage but had no objections to residents maintaining the alley.

### **18. REPORTS FROM MEMBERS**

Cllr Mould reported that there is currently a consultation on the proposal for The Cherries Nursery to join formally with Newington CEP School to create a two- eleven years provision in the village and safeguard the future of the nursery. There is a lot going on at the school, there is an external classroom, a running track and an amphitheatre is being installed.

Cllr S Harvey said there is a KALC Swale Area Committee meeting next week and that he has suggested that a representative from Southern Water be invited to report back following the water outage in Newington in January and then the recent water outage on the Isle of Sheppey.
