Cllr Harvey informed Members that a decision is yet to be made.

Proposal: Erection of a single storey rear extension to existing dwelling house with other associated external works.

Cllr Harvey reported that a decision is yet to be made.

<u>Proposal:</u> Conversion of garage to a workshop and home office, including replacement of roof and insertion of 3no. windows to side and 2no. rooflights. Partial demolition of existing stable building and erection of access stairs to garden.

Cllr Harvey reported that the application has been permitted.

Application: 20/505059/FULL: Willow Trees, 111 High Street, Newington ME9 7JJ Proposal: Demolition of existing chalet bungalow and erection of 20 dwellings (4 x two bedrooms and 14 x three-bedrooms and 2 x four-bedrooms) with associated access, parking, amenity and landscaping.

Cllr Harvey informed Members that he has been trying to contact the planning officer as this is a new application. A decision is yet to be made.

Proposal: Variation of Condition 2 and removal of Condition 11 of application 17/504342/FULL (Retrospective demolition of former Working Mens Club and erection of 9no. dwellings and 1no. maisonette together with carports for garaging of cars (Revised scheme). (Vary Condition 2 to include reference to 'Titan-Sonair' ventilation system to bedrooms and dining room fronting the high street.)

Proposal: Retrospective application for the erection of a first floor rear extension, loft extension and lean to roof at front and side of dwelling (resubmission of 18/502531/FULL). Cllr Harvey reported a one year enforcement notice has been served.

Ref: 20/503637/FULL Medway Autos, Christine & Muriel, London Road Upchurch ME9 7PD Proposal: Change of use of auto showroom and workshop (Sui generis) to a banqueting hall, with food processing and distribution (Class D2 and B2), including the creation of a mezzanine floor and alterations to fenestration. Change of use of 2no. residential bungalows (C3) to guest accommodation (C1) associated with the banqueting hall, including the erection of a single storey rear extension and loft conversion, including 2no. rear dormers and installation of 4no. rooflights to front. Erection of a wedding gazebo to rear of bungalows

Cllr Harvey said permission has been granted for a wedding venue.

Proposal: Change of use from agricultural land to a mixed use of agriculture and leisure activities including 6 days of bootfairs and 331 days for outdoor/drive in cinema, open air theatres/circus, weddings, motoring shows/events over and above the number of days allowed as permitted development under Schedule 2, Part 4, Class B of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) Cllr Harvey said the issue has been resolved.

Proposal: Outline Application with all matters reserved for the proposed development of six houses and three bungalows.

Cllr Harvey informed Members that a decision is yet to be made.

Ref: 17/505711/HYBRID Land at Wises Lane Borden Kent ME10 1GD

Hybrid planning application with outline planning permission (all matters reserved except for access) sought for up to 595 dwellings including affordable housing; a two-form entry primary school with associated outdoor space and vehicle parking; local facilities comprising a Class A1 retail store of up to 480 sq m GIA and up to 560sqm GIA of "flexible use" floorspace that can be used for one or more of the following uses - A1 (retail), A2 (financial and professional services), A3 (restaurants and cafes), D1 (non-residential institutions); a rugby clubhouse / community building of up to 375 sq m GIA, three standard RFU sports pitches and associated vehicle parking; a link road between Borden Lane and Chestnut Street / A249; allotments; and formal and informal open space incorporating SuDS, new planting / landscaping and ecological enhancement works. Full planning permission is sought for the erection of 80 dwellings including affordable housing, open space, associated access / roads, vehicle parking, associated services, infrastructure, landscaping and associated SuDS. For clarity - the total number of dwellings proposed across the site is up to 675 - Cllr Harvey said there was no further update.

Address: Land To The Rear Of Eden Meadow Newington Kent ME9 7JH Proposal: Erection of 20No. residential dwellings and associated car parking, hardstanding, landscaping and open spaces, infrastructure including SuDs and earthworks accessed from the existing junction serving Eden Meadow from the A2 High Street. Cllr Harvey said the Council's response has been submitted.

iii. Ref: 21/501791/PIP

Address: Land At 164 Bull Lane Newington Sittingbourne Kent ME9 7NB Proposal: Permission in Principle for the erection of a detached two storey sustainable selfbuild or custom building dwelling with new access onto Bull Lane

Councillors considered the proposal and noted the new dwelling is outside the built-up area. Cllr Harvey **PROPOSED** to object to the application; **SECONDED** by Cllr Layer: **AGREED UNANIMOUSLY**.

Proposal: Single storey rear extension

Proposal: Erection of a part single storey, part two storey rear extension and extension to existing porch

Proposal: Erection of a first floor front extension.

viii. Foxchurch, near Bobbing

Cllr Harvey said the developer is finalising the plans before submitting an application for two and a half thousand homes.

Councillors considered correspondence regarding memorial trees planted in 2002 which had been removed last year due following advice from specialist. There is no record of memorial trees so it was not possible to contact the families.
