NEWINGTON PARISH COUNCIL

Minutes of the Parish Council meeting held in the Newington Room, Newington Village Hall on 30 November 2021

Present: Cllr Tony Mould (Vice Chairman), Cllr Steve Godmon, Cllr Stephen Harvey, Cllr Eric Layer and Cllr James Morgan; and Mrs Wendy Licence (Clerk)

Also present was County Councillor Mike Baldock.

In the absence of the Chairman Cllr Mould took the chair. Cllr Mould welcomed everyone to the meeting.

1. COUNCILLOR VACANCIES

Cllr Mould reported that no applications have been received yet.

2. APOLOGIES FOR ABSENCE

Apologies had been received from Cllr Richard Palmer (personal) and Cllr Elaine Jackson (self-isolating); apologies accepted.

Apologies had also been received from Ward Member Alan Horton (at another meeting); apologies noted.

3. DECLARATIONS OF INTEREST

None were declared.

4. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 26 OCTOBER 2021

Cllr Harvey **PROPOSED** to accept the minutes as a true record of the meeting; **SECONDED** by Cllr Morgan: **AGREED UNANIMOUSLY**. Cllr Mould duly signed the minutes as a true record.

5. MATTERS ARISING FROM THE MINUTES

Cllr Mould reported the light is alley has been repaired. One bench has been installed and the picnic bench and two other benches have an estimated delivery date of week commencing 6 December. The tree near the Bull Lane light is the responsibility of 1 Dennis Willcocks Close.

Advice has been sought from Prof Stephen Peckham and Amenities has suggested that £5,000 be budgeted for expert advice.

Cllr Harvey said the expert advice will initially be concerning air quality issues and possible other matters.

6. PUBLIC QUESTION TIME

No members of the public were present.

7. VISITORS

i. Borough Councillors

SBCllr Horton was unable to attend and sent the following report:

Nothing of specific note to report this month, it has just been the routine business of a Councillor. Having said that the one notable exception was the opportunity to join the Newington History Group along with many others for the dedication of the Peace Tree at the Recreation Ground. It was an excellent turnout and a fitting ceremony involving some of the youngest in our community, I would

like to express my thanks and congratulations to the History Group for their work within the village and beyond.

I am happy to pick up any issues regarding the planning report and discussion, outside of the meeting.

ii. County Councillor

KCCllr Baldock reported there had been a public meeting which investigated a high wall along the A2, there had been concern regarding the quality of the wall, and it was found there was no danger and the situation will be monitored.

KCCllr Baldock reported that SBCllr Palmer has been looking at the possibility of getting a Red Route in Newington High Street, there is a precedence of this outside London.

The Swale Parish Group met earlier in the month, Cllr Palmer was the Parish Council's delegate at that, the next meeting is in March 2022. Funding was discussed and there is still some members' grant funding available. Parish Councils can apply for funding for youth and community groups for £300- £2,000.

Sarah-Jayne Ellcock (KCC) has moved departments, her role is being covered by the Maidstone Schemes Project Manager. Ms Ellcock worked with parishes on their Highways Improvement Plans.

Cllr Harvey said it had been agreed that railings would be installed in the High Street and the lines outside the school would be renewed.

ACTION: Clerk to send KCCllr Baldock details.

Cllr Harvey said the S106 money from Persimmon for youth work had been allocated to Tunbridge Wells rather than locally. An audit has been requested regarding the statute provision and locally and soon after the Youth Club started in Newington but this is for children, there is nothing for teenagers. There is a concern that anti-social behaviour could become an issue, already the lights from the Persimmon development have been smashed, the parish just wants what is due to it. The planning application for 128 High Street mentions youth provision but the developer has not liaised with the Parish Council. The Parish Council would be willing to provide a youth worker if necessary.

KCCllr Baldock said he did raise the matter and it is being looked into, he will follow this up. KCCllr Baldock reported that the Happy Pants application will go to the next Planning Committee.

Lots of Parish Council have Councillor vacancies, this needs to be looked at as a number of Councillors may stand down in 2023, KALC will be asked for recruitment guidance.

KCCllr Baldock reported that he and SBCllr Palmer are not in favour of the proposed withdrawal of the street lighting funding to Parish Councils. Parish Councils need to write to the Leader of Swale Borough Council and explain the pressure this puts them under; this proposal is not a result of consultation with the Parish Councils.

Cllr Harvey said Swale Borough Council used to send paper copies of plans to the Council and this stopped because of COVID but has not been reinstated since restrictions lifted. Parish Councils and Councillors do not have the means to print the plans which are vital when discussing the applications at meetings. Councils and Councillors should not subsidise Swale Borough Council for this.

KCCllr Baldock said this is another funding issue and is currently under discussion, there is possibly a £2,000,000 shortfall in Swale's budget.

9. AMENITIES COMMITTEE

i. To receive the minutes of the meeting held on 23 November 2021 and to receive an update Cllr Layer reported that Biffa has been instructed to increase their visits to empty the dog waste bin by allotments, although it had not been emptied today and is an ongoing issue. The tree saplings have been ordered. The Newington History Group has agreed to install a proper tree guard around the Peace Tree by the end of the year. The Playing field has been cut today. Georgina Springall, the Community Warden, has ascertained where the owner of the dogs which damaged the Crusader swing lives and will make a joint visit with PCSO John Cork and will report back. Ms Springall is also trying to source some anti dog-fouling signs.

The work at pavilion has been completed including a new water heater for the Parish Room, this was £575 more than the quote accepted but still within the grant funding. After the flooring is laid, there will be £305 left from the grant funding. The tree surgeon will fell the trees in the Community Woodland in January.

Cllr Mould thanked Cllr Layer for his report.

12. CHURCHYARD AND CEMETERY

Cllr Layer reported there is a Policy Briefing document from NALC on Defra's Consultation on Amendments to the Environmental Permitting (England and Wales) Regulations 2016 as applied to Groundwater Activities and related Surface Water Discharge Activities. The Council can apply for exemption, due to the small numbers of burials, when this becomes law. Cllr Layer said a group want to plant wildflowers in the church yard to rewild it as part of Caring for God's Acre and now there is a suggestion to have picnic benches, costing £110- £200 each, in the church yard and also a seat around the oak tree. An application for a grant has been made to the Wickham Trust and the Trust has said there must be agreement from the Parochial Church Council and the Parish Council.

Cllr Harvey said the Council had an ecologist give advice on rewilding, wildflowers plant themselves.

Cllr Harvey **PROPOSED** that the Council grants permission for benches to be installed if the church accepts responsibility and liability for the benches; **SECONDED** by Cllr Layer: **AGREED UNANIMOUSLY**.

ACTION: Clerk to write to the Rector.

Cllr Layer said there will be a Cemetery Working Party in the Spring.

14. NEWINGTON AIR QUALITY MANAGEMENT AREA

Cllr Harvey reported that he had contacted Prof Stephen Peckham and his colleague, Dr Mills, is assessing the raw data from the air quality monitors and the reports from Lustre Consulting. The Lustre report on 128 High Street is out of date. The University of Kent is looking at writing a generic report which could be used with regards to all applications. A traffic survey is needed regarding the land next to the school, the NPPF states there should be traffic counts for all considerable proposals.

15. STREET LIGHTING

Cllr Layer said the owner of the tree obscuring the light in Bull Lane has been ascertained. *ACTION: Clerk to write requesting the tree be cut back.*
