Road Traffic Regulation Act 1984

Notice is hereby given that the KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Section 1(1) and (2), 2(1) to (3) and 4(1) and (2) of the Road Traffic Regulation Act 1984 as amended, (hereinafter referred to as 'the Act') and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby proposes to make the following order;

The effect of the proposed named Order will be to prohibit the movement of vehicles in to and on the following length of road in Newington, Swale:-

Roads in Newington in the Borough of Swale

BULL LANE – Prohibit the right-hand and left-hand turn movements from the High Street into Bull Lane. One Way from its junction with The Willows to its junction with High Street. No entry to Bull Lane at its junction with High Street.

ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Section 1(1), and (2), 2(1) to (3) and 4(1) and (2) of the Road Traffic Regulation Act 1984 as amended, (hereinafter referred to as 'the Act') and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby proposes to make the following order;

Commencement and Citation

- 1. No person shall, except under the direction or with the permission of a police constable in uniform, cause or permit any vehicle (excluding pedal cycles) to make a right-hand turn movement from High Street (east bound) into Bull Lane or make a left-hand turn movement from High Street (west bound) into Bull Lane, Newington, Swale.
- 2. No person shall, except under the direction or with the permission of a police constable in uniform, cause or permit any vehicle (excluding pedal cycles) to proceed along Bull Lane, Newington from its junction with High Street to its junction with The Willows in a south westerly direction.
- 3. No person shall, except under the direction or with the permission of a police constable in uniform, cause or permit any vehicle (excluding pedal cycles) to enter Bull Lane, Newington at its junction with High Street (south-west bound).
- 4. Nothing in Articles 1, 2 and 3 shall apply to any vehicle on an occasion when it is being used for Fire Brigade, Ambulance or Police purposes (in the event of an emergency), if the observance of that provision would be likely to hinder the use of that vehicle for the purpose for which it is being used on that occasion or a vehicle in the service of the local authority in the course of road cleansing or gully emptying.
- 5. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act.
- 6. The provisions of this order shall prevail over the provisions of any previous order.
- 7. This Order may be cited as "The Kent County Council (Bull Lane, Newington, The Borough of Swale) (Prohibition of Traffic Movements) Order 2021" ('this Order') and shall come into force on the day of 2021.
